10. MAYOR'S REPORT -

- Reminder to Council Members Financial Statement deadline is May 15th.
- The Mayor appointed Bryan Kepler to a position of Acting Deputy Service Director for a probationary period of 6 months. Until then, we do not have a Road Superintendent. He would like to write a Memo of Understanding with Teamsters 348 to pay an extra \$1.50 per hour "Out of Classification" pay to a Road Maintenance Worker to supervise when Mr. Kepler is on vacation or off sick. The Road Superintendent position will not be filled until the appointment of the Deputy Service Director, which could be Mr. Kepler. At that time, a current Road Maintenance Worker will be asked to apply for the Road Superintendent position.
- This will leave an opening for one or two Road Maintenance Workers. The Mayor will request the Civil Service Commission to advertise for the vacancy. One of the current workers will probably move up as Road Superintendent, one is expected to retire, and one is expected to be called to serve in Afghanistan for another tour. Just as a reminder, we currently have 5 Maintenance Workers and two of them receive five weeks of vacation each plus Bryan receives 5 weeks of vacation. The Mayor does not want to fall short this winter.

- Litter Clean Up day will be April 22, 2017
- Fisherman's Central purchased the plaza where the old Sparkle Market was located.
- A sidewalk will be placed on the property at the corner of Southcrest and Manchester Road.
